Dear NuView Academy Community,

After taking into consideration the increasing prevalence of COVID-19 exposure and infection in the community at large and among ESCNJ faculty, staff, and students in particular, our Superintendent has decided to close all ESCNJ schools/programs for in-person instruction. The closure of in-person instruction, and the transition to remote instruction, will be from Monday, November 30, 2020 through Friday, January 15, 2021. This decision was made in collaboration with the Middlesex County Office of Health, the Middlesex County Office of Education, and following the NJ Department of Health guidelines. The current plan is for students to return to school for in-person instruction on Tuesday, January 19, 2021.

Your teachers and therapists are ready to implement remote instruction/therapy without delay during this period. Instruction/therapy will be provided following the classroom schedule being sent home with your student. Work material for your student to complete during this period is also being sent home with them. Your student's teacher and therapists will contact you on Monday November 30, 2020 with all additional information about your student's remote instruction/teletherapy sessions.

Your teachers and clinicians will be available to provide you and your student any supports or resources you may need during this challenging period. Your teachers and therapists will continue to provide high quality instruction/therapy to support your student's academic, behavioral, and social/emotional needs, and to minimize the disruption to learning. Should you have any questions about your local school district's lunch program, please contact your ESCNJ case manager for assistance.

For those students who have chosen to participate in remote instruction since the beginning of the school year, your teachers and therapists will do their utmost to continue to provide instruction according to their established schedule. However, some changes may be inevitable due to the transition to remote instruction for all students. We appreciate your support in making this transition a smooth process for all students.

As always, the health and wellbeing of our students, staff, and community is our top priority. Should conditions within the community improve and we are able to safely transition back to in-person instruction, we will do so as quickly as possible. I will stay in contact with you on a weekly basis during this remote instruction period.
