



# ZT2000 36 months / 500 HOUR LIMITED WARRANTY

# General Provisions and Certain Responsibilities of Purchaser

Bobcat Company provides the warranty described below to the original purchaser of a new Bobcat® ZT2000 riding mower from any authorized Bobcat dealer. Bobcat Company responsibility under this limited warranty is restricted to repairing or replacing, at its option, any covered part found to be defective in material or workmanship during the warranty term specified herein. Warranty service must be performed by an authorized Bobcat dealer. Warranty service will be performed without charge to the purchaser for parts and labor. The purchaser will be responsible, however, for the cost and expense of transporting the mower, part or accessory to and from an authorized dealer's service center, for any premium charged for overtime labor requested by the purchaser and for any service and/or maintenance not directly related to any defect covered under this limited warranty. Proof of purchase will be required by the authorized dealer to substantiate any warranty claim. This limited warranty is transferable, provided an authorized Bobcat dealer is notified of change of ownership and authorizes such transfer, but the warranty term commences upon the date of the original purchase. # 2-STEP DEALER FLOORPLAN TERMS

# **Objective**

Floorplan programs provided through Wells Fargo Commercial Distribution Finance (CDF) should be used by the distributor to facilitate sales and ensure that dealers carry representative levels of the full line of Bobcat products throughout the year in order to meet retail sales. Distributors may floorplan product invoiced to dealers on floorplan by the distributor, as well as distributor paid inventory.

# **Program**

The following terms and conditions are in effect for all shipments of serialized product and related accessories under the floorplan arrangement, which the Distributor may have with CDF. These floorplan terms are not consignment or guaranteed sales arrangements. Floorplan terms cannot be used in lieu of retail financing or delayed payments for the customer.

All products are due when sold or at the maturity date, whichever comes first.

Distribution can extend floorplan terms to fit their markets, at their own expense, working with CDF directly.

# **Eligibility**

Dealers must meet qualifications established by Doosan Bobcat Johnson Creek and CDF. Use of the plan numbers below is determined by the specific Doosan Bobcat Johnson Creek Marketing Programs that utilize them. All serialized product sales must be warranty registered prior to leaving Dealer inventory.

These programs supersede all current published programs. Doosan Bobcat Johnson Creek reserves the right to withdraw or modify the above programs at any time with proper notice to the channel. This program can not be used in conjunction with any other sales programs or discounts.







# **Demonstrator Program - Dealer**

To increase product visibility and to provide hands on proof that Bobcat and Ryan produces the most productive line of turf renovation equipment in the industry today, Doosan Bobcat Johnson Creek offers the following Demo Program for Dealers:

Bobcat and Ryan Dealers may designate up to two (2) units per brand annually with prior approval from your district manager. The demo units must be designated as a demo unit when ordered so it can be correctly billed for floorplan financing purposes and is not included in units ordered to become an Authorized dealer or booking qualification. All demo units must be written on a separate order.

Demo Unit will receive - 5% Demo Discount on the invoice from standard dealer cost.

# **Terms & Conditions:**

- All Demo orders must be placed separately and listed as a demo order on top of the purchase order. All units must be clearly marked as "Demo Unit".
- The dealer will receive free floorplan for 180 days from time of purchase.
- Demos are designed to help you close more sales. The Demo unit should be used a minimum of 50 hours and a maximum of 150 hours prior to retail.

# **Demonstrator Limited Warranty**

The start date will default to the date credit is issued against a unit for demonstrator use. At the time of the sale the purchaser will receive the remainder of the warranty that's available.

All demonstration orders must be placed on a separate order and after the qualifying dealer's order has been placed.







# **Bid Assistance Program**

The Bobcat and Ryan Tax Exempt Bid Assistance Program has been established to enable Bobcat and Ryan Dealers to compete for and make sales in which Bobcat and Ryan products will be highly visible in use. Bid assistance is available on sales to the following organizations:

- 1) **Non-Profit** Churches, church supported schools, church supported cemeteries, etc. a) IRS exemption number required

  - a) Bobcat/Ryan equipment purchased is to be used exclusively for the fulfillment of a contract that was awarded only to a tax-supported or state-regulated agency that is eligible to receive Bid Assist discount. Non-profit groups are not eligible.
  - b) Awarded Contract is for a minimum of 12 months with at least six (6) months remaining on the contract.
  - c) Copy of eligible contract must be attached along with all other documentation.
  - d) Prior Approval must be obtained to utilize this feature. Contracts may be verified as needed.

# 2021 Co-Op Program

The 2021 Co-Op allowance will be one percent (1%) of wholegood purchases of Bobcat (white) mowers, less returns per quarter. At the start of each quarter, Dealers will begin accruing their Co-Op allowances. These Co-Op funds must be used by the end of the quarter, as each subsequent quarter is treated as a separate entity from the next.

All Co-Op Advertising Claim Forms must be submitted to Marketing (claims@stevenwillandinc.com) no later than 30 days following the close of each quarter. All Co-Op advertising under this program <u>must</u> have prior approval from a Doosan Bobcat Johnson Creek Regional Sales Manager.

Dealer account with Doosan Bobcat Johnson Creek and Wells Fargo must be in good standing. The development programs for which you request reimbursement must fully comply with the Co-Operative Advertising Program guidelines contained in this document.

Doosan Bobcat Johnson Creek will share eligible Co-Op costs on a 50/50 basis with Dealers, up to the 1% allowance.

# Eligibility

- Alcoholic beverages
- The cost of golf tournaments, donations, or payment of association dues
- Costs associated with Bobcat/Ryan/Steiner Service Schools when conducted by a
  Doosan Bobcat Johnson Creek field service representative. Since Doosan Bobcat

  you, additional costs associated with these schools are considered the
  responsibility for the Dealer.
