TERMS AND CONDITIONS

Prices and Payment

All prices shown in this price list are suggested retail prices and are subject to change without notice. Prices do not include sales taxes, shipping, delivery, special packaging, assembly, storage or installation. These prices are guaranteed for 30 days from the date of quotation and are firm and final after acceptance of the order. Orders are invoiced at the time of shipment. A 50% deposit (on material only) is required on all projects, though NxtWall may waive the charge on a case-by-case basis. Terms of payment are net 30 days from date of invoice. Any products sold by NxtWall shall remain its property until fully paid in cash. In the event that the purchaser defaults in the payment of any sum due to NxtWall, or in the event the purchaser's financial condition becomes unsatisfactory to NxtWall, NxtWall reserves the right upon notice to the purchaser, to differ or discontinue shipment of any goods or, to refuse any order until time as the default is corrected or the purchaser provides assurance of payment to NxtWall.

Orders

NxtWall requires that all orders be submitted in writing to avoid errors and/or duplication. The purchaser is responsible to submit complete orders. Incomplete or incorrect orders (finishes, door types, glass types missing, etc...) will be processed upon receipt of the complete information and normal production lead-time will be applied from the date that the complete information is received.

Acknowledgments

Orders will be acknowledged with NxtWall acknowledgement forms governing the transaction. The details appearing on this acknowledgement will describe the items to be shipped to the purchaser and the ready to ship date (not the actual shipping date). It is the purchaser's responsibility to verify that the acknowledgement information is correct. If not, the purchaser must notify NxtWall within 48 hours in writing. Failure to provide corrections within 48 hours could be subject to extra charges (See Changes and Cancellations).

Liability

Buyer agrees to inspect the goods immediately upon receipt of such goods from Seller. If any item of goods that is manufactured by Seller and is not subject to alteration, improper installation, abuse or misuse proves to be defective (as defined below) within five days following the date of shipment and prior to installation (in the case of a patent defect) or one year following the date of shipment (in the case of a latent defect), and if Buyer gives written notice to Seller of such defect within that period and does not alter the goods, then Seller shall, at Seller's option, either repair or replace the defective item, at Seller's expense. Seller shall not be responsible for the expense of locating or removing the defective goods or reinstalling any repaired or replacement goods. Notice of a breach of Seller's warranty must be made in writing addressed to Seller, setting forth sufficient detail to permit identification by Seller of the claimed defect. Samples should accompany such notification. If Buyer alters the goods or fails to notify Seller within the one year period following shipment of the goods, or if the goods are installed improperly, then any claim for breach of warranty shall be conclusively deemed to have been waived by Buyer with respect to the alleged

In the event of a defect in any goods constituting a breach of the warranty provided herein, Seller shall furnish instructions for the disposition of the defective goods. Seller shall have the option of requiring the return of the defective goods, transportation prepaid, and proof that the goods were not altered or subject to misuse or abuse to establish the claim. No goods shall be returned to Seller without its prior consent. The acceptance of any goods returned to Seller shall not be deemed an admission that the goods are defective or in breach of any warranty, and if Seller determines that the goods are not defective, they may be returned to Buyer at Buyer's expense. Neither Buyer nor any other person may modify or expand the warranty provided herein, waive any of the limitations, or make any different or additional warranties with respect to the goods. Any statements to the contrary are hereby rendered null and void unless made in a writing signed by an authorized officer of Seller.

TERMS AND CONDITIONS

Limitations

Except as stated in the "Liabilities" and "NxtWall 10 Year Warranty" sections, Seller does not make any warranty as to the goods or services and, in particular, does not make any warranty of merchantability or fitness for any particular purpose, and Buyer is solely responsible for determining the proper application and use of the goods. Seller's warranty applies only to goods that it manufactures. All other goods are sold AS IS, without warranty; provided, however, that Seller assigns to Buyer any warranties provided by the manufacturers of such goods, to the extent that they are assignable. Seller shall not have any tort liability to Buyer or any other person with respect to any of the goods and shall not be liable for consequential, incidental, special, exemplary, indirect or punitive damages arising from any product defect, delay, nondelivery, recall or other breach.

Indemnity

Buyer shall indemnify and hold harmless Seller with respect to all damages, losses, claims and expenses, including attorney fees, that Seller incurs as a result of Buyer's breach of any of Buyer's obligations under these Terms of Sale or any claimed unfair competition or patent, trademark or copyright infringement or any other claim resulting from Seller's manufacture of the goods, or performance of the services, to Buyer's specifications.

Seller shall indemnify and hold harmless Buyer with respect to all damages, losses, claims and expenses, including attorney fees that Buyer incurs as a result of Seller's breach of any of Seller's obligations under these Terms of Sale.

Time for Bringing Action

Any action that Buyer brings against Seller for breach of this Agreement or for any other claim that arises out of or relates to the goods or their design, manufacture, sale or delivery or the services must be brought within one year after the cause of action accrues.

Applicable Law

This agreement between Seller and Buyer shall be considered to have been made in the State of Michigan, and it shall be governed by and interpreted according to Michigan law. Either party may bring any action that arises out of or relates to this agreement in any federal or state

court in Kalamazoo, Michigan that has jurisdiction of the subject matter, and Buyer irrevocably consents that any such court shall have personal jurisdiction over Buyer and waives any objection that the court is an inconvenient forum.

Complete Agreement; Amendment

If Buyer has not otherwise agreed to these Terms of Sale, then Buyer's acceptance of delivery of, or payment for, the goods or services shall constitute Buyer's agreement to these Terms. This agreement will not be amended or supplemented by additional or inconsistent terms contained in a purchase order or another standard form. The terms on Seller's quotation and acknowledgment and these standard Terms of Sale contain the entire agreement between Buyer and Seller. Any change in this agreement must be by a writing signed by an authorized officer of Seller. The parties agree that only the President of NxtWall, is authorized to bind the Seller to any changes to the contract.

Codes

NxtWall walls are considered movable demountable walls, subject to local fire and building codes. Installation and use of the walls in accordance with all local, applicable codes is the responsibility of the customer.

UL Listing

NxtWall walls can accept any UL Approved electrical system determined by the customer. NxtWall is not responsible for confirming that product utilized meet code requirements. This determination may be subject to local building codes.

Storage

NxtWall reserves the right to invoice the purchaser for storage charges in specific cases.

Changes and Cancellations

Orders that have entered any stage of production cannot be cancelled without penalty. Order changes must be in writing, and upon review a decision will be made if the change can be accepted.

TERMS AND CONDITIONS

Shipping

- A) Prices are F.O.B. Origin, prepaid and add to single continental U.S. location. Shipments to Alaska, Hawaii and other overseas shipments are prepaid and add to U.S. port of embarkation.
- B) NxtWall will choose the carrier unless otherwise specified by the purchaser. Goods will be handed over to the common carrier in good condition; NxtWall liability ceases at this point. Shipping will be done to the purchaser's unloading dock. The purchaser should have an unloading dock able to accommodate 53' trailers and must supply the unloading personnel.
- C) Claims: NxtWall is not responsible for damage that incurs in transit or in storage. It is the purchaser's responsibility to examine goods upon receipt and to file any claims with the carrier could result in the carrier refusal to honor the charges. It is the purchaser's responsibility to obtain information on the carrier's claim policies and to send any claims to the carrier. For other policies, contact Customer Service.
- D) It is the purchaser's responsibility to file any claims even if the order has been shipped directly to the client.

Return of Goods

- A) No merchandise may be returned without NxtWall's written consent and shipping instructions. If this procedure is not followed, the merchandise will not be accepted by the factory and will be reshipped collect without further notice.
- B) Goods must be returned properly packaged and all boxes must be clearly marked with the authorization number.
- C) Returns of items authorized by NxtWall are subject to a charge of 25% plus freight (& customs if applicable) and repair costs.

Product Specifications

NxtWall reserves the right to modify the specifications of products, materials, design or accessories without notice. NxtWall also reserves the right to cease production of any product at any time. The products, accessories, materials and finishes as described in the price list prevail over the content of brochures or folders.

NxtWall 10 Year Warranty

NxtWall warrants its products are free of defects in design, material and workmanship for 10 years with original purchaser.

If written notice of the defect is given to NxtWall within the applicable warranty period, NxtWall will repair or replace with comparable product, at NxtWall's option, without charge to the original purchaser.

This warranty provides limits on the following products:

- NxtWall wall board laminates which are warranted for (5) five years from date of delivery
- moving and high wear parts such as covering materials/finishes, hinges, coverstrips, sliding door rollers, etc, which are warranted for (5) five years of single shift usage from date of delivery
- non-standard products, which are warranted for (1) one year from date of delivery.

This warranty does not extend to:

- Customer's Own Material (COM) or special finishes applied to NxtWall's products,
- product which has been modified or has not been installed or used according to NxtWall's application and installation guidelines.

On products warranted for a specified number of years of single shift usage, the warranty period will be reduced in a pro-rata manner when the products are used in a manner that exceeds the equivalent of a single shift forty (40) hour work week.

This warranty is the Customer's sole remedy for product defect. This warranty does not cover damage by a carrier in transit. NxtWall makes no warranties, including the implied warranties of merchantability or fitness for a particular purpose, other than the express warranties contained herein. There are no other warranties expressed or implied. NxtWall shall not be liable for consequential or incidental damages arising from any product defect.




