Dear Parents/Guardians;

We are rapidly approaching the start of the new school year and with that a feeling of hope for better times with a return to a sense of “normal” for all of us. The faculty and staff have been working diligently to prepare the school for the students’ arrival this Fall.

On August 13, 2020 Governor Murphy and the NJ Department of Education (NJDOE) gave schools the ability to open in a remote instructional fashion due to any ongoing Health and/or Safety concerns with implementation of the NJDOE Road Back Restart & Reopening Plan. As such, NuView Academy has made the following changes to our school calendar and schedule:

**September 4, 2020 – Remote Only Instruction Begins for All Students
Between the Hours of 8:30 AM – 2:15 PM.**

**September 21, 2020 – In-person Instruction Begins for Those Students Who Chose to
Return to School. Remote Instruction Continues for Those Students Remaining Home.**

September 21 thru September 25 are Early Dismissal Days.

September 23 is Virtual Back-to-School Night.

Monday, September 28 NuView Academy closed.

Full day schedule resumes Tuesday, September 29 Hours of 8:30 AM – 2:15 PM.
